Tue-Thur: Jan. 9-11 <i>(Council meets Jan. 29-Feb 1 in New Orleans, LA)</i>	Tampa, FL	Luiz Barbieri and Bob Gill have scheduling conflicts.
Mon-Tue: Mar. 26-27 <i>(Council meets April 16-19 in Gulfport, MS)</i>	Tampa, FL	Moved to Mon-Tue, March 26-27 to avoid travel conflicts by some attendees with 2018 Saltwater Recreational Fisheries Summit (March 28-29) . Also, to avoid possible travel conflicts due to Easter weekend (April 1)
Wed-Fri: May 30-June 1 <i>(Council meets June 18-22 in Key West, FL)</i>	Tampa, FL	Meeting moved to Wed-Fri to avoid conflict with Memorial Day weekend. If it is a 2-day meeting, it will be Thur-Fri.
Tue-Thur: Jul. 31- Aug 2 <i>(Council meets August 20-23 in Corpus Christi, TX)</i>	Tampa, FL	August 2 conflicts with LWF Commission meeting
Tue-Thur: Oct 2-4 <i>(Council meets Oct. 22-25 in Mobile, AL)</i>	Tampa, FL	October 4 conflicts with LWF Commission meeting

- January: Review Coral Amendment 9, Grouper/Tilefish 5-year IFQ review, Evaluating Robustness of HCRs to future red tide events, Spawning aggregations in the Gulf of Mexico, Red grouper indices of abundance, Status Determination Criteria/OY options paper, Carry-over of unused ACL
- March: Texas shrimp closure analysis, Grouper/Tilefish IFQ 5-year review, 5-year review on inclusion/exclusion of species in FMPs, Update on MRIP, Habitat mapping of wFL shelf
- May: SEDAR 37 (hogfish update assessment); SEDAR 51 (gray snapper benchmark assessment); SEDAR 52 (red snapper standard assessment)
