Motion: Per the IPT's suggestion, in Action 4 that a new Alternative 5 and Alternative 6 be included in the document.

Alternative 5: Establish a provision allowing transit through areas closed to king mackerel fishing for vessels possessing king mackerel that were legally harvested in the EEZ off areas open to king mackerel fishing.

Alternative 6: Establish a provision allowing transit through the Florida west coast Northern Subzone when that area is closed for vessels possessing king mackerel that were legally harvested in the EEZ off Collier County.

New language in Alternative 3:

This pertains to:

Responsibilities of Each Council:

1. Recommendations with respect to the Atlantic migratory groups of king mackerel, Spanish

mackerel, and cobia will be the responsibility of the South Atlantic Council, and those for the Gulf migratory groups of king mackerel, Spanish mackerel, and cobia will be the responsibility of the Gulf Council, with the following exceptions:

- a. The South Atlantic Council will have responsibility to set vessel trip limits, closed seasons or areas, or gear restrictions for (1) the Eastern Zone East Coast Subzone for Gulf migratory group king mackerel and (2) the east coast of Florida including the Atlantic side of the Florida Keys for Gulf migratory group cobia.
- 2. For stocks where a stock assessment indicates a different boundary between the Gulf and Atlantic migratory groups than the management boundary, a portion of the ACL for one migratory group may be apportioned to the appropriate zone, but management measures for that zone will be the responsibility of the Council within whose management area that zone is located.
- 3. Both councils must concur on recommendations that affect both migratory groups.

Motion carried with no opposition.

Motion: To add Action 7 to the document in its entirety with the added changes.

Action 7. Modify the Gulf and Atlantic Migratory Group Cobia Annual Catch Limits (ACLs) and Annual Catch Targets (ACTs).

Alternative 1: No Action. The entire Gulf migratory group cobia ACL applies to the Gulf Council jurisdictional area and the entire South Atlantic migratory group cobia ACL applies to the South Atlantic jurisdictional area. The ACLs and ACTs that were established by Amendment 18 are as follows:

The entire Gulf migratory group cobia ACL applies to the Gulf Council jurisdictional area and the entire South Atlantic migratory group cobia ACL applies to the South Atlantic jurisdictional area. The ACLs and ACTs would be as follows:

Alternative 3: The ACL = ABC for each migratory group. The ACL for each jurisdictional area would be determined as follows:

• The Gulf migratory group cobia ACL (based on the ABC as determined by the SSC) would be divided into a Gulf jurisdictional ACL and an east coast of Florida ACL based on the options below.

Option a: Use 2002-2012 landings to establish the percentage split for the Gulf ABC.

Option b: Use 2008-2012 landings to establish the percentage split for the Gulf ABC.

Option c: Use Boyles law (which years?) 50% of landings from 2002-2011 + 50% of landings from 2009-2011?

Option d: Use 1998-2012 (15 years)

Option e: (*Based on yellowtail*): 50% of average landings from 1993-2008 + 50% of average landings from 2006-2008 (75% SA and 25% Gulf)

Option f: (*Based on mutton*): 50% of average landings from 1990-2008 + 50% of average landings from 2006-2008 (82% SA and 18% Gulf)

• The South Atlantic jurisdictional area ACL would be the ACL for the Atlantic migratory group cobia (based on the ABC as determined by the SSC) plus the portion of the Gulf migratory group ACL for the east coast of Florida.

Amendment 19 – Joint GMFMC/SAFMC Committee Meeting

Motion: To add "in or from the EEZ of the Gulf of Mexico or Atlantic" to line 2 of Alternatives 2 and 3 of Action 1.

Motion carried with one opposed.

Motion: In Action 1, to add a new Alternative 4.

Alternative 4: Prohibit sale of king and Spanish mackerel caught under the bag limit with the exception of state-permitted tournaments. For a person to sell king or Spanish mackerel in or from the EEZ of the Gulf of Mexico or Atlantic, those fish must have been harvested on a commercial trip aboard a vessel with a commercial vessel permit/endorsement. A king mackerel permit is required to sell king mackerel and a Spanish mackerel permit is required to sell Spanish mackerel. King or Spanish mackerel caught during a tournament may be donated to a dealer in exchange for a charitable donation if the tournament organizers have a permit from a state to conduct that tournament, and transfer and reporting requirements are followed.

Option a. The South Atlantic Council's jurisdiction

Option b. The Gulf Council's jurisdiction

Motion carried with no opposition.

Motion: In Action 1, that the Gulf Council's preferred alternative be Alternative 3, Option b.

Gulf Preferred Alternative 3: Prohibit sale of king and Spanish mackerel caught under the bag limit. For a person to sell king or Spanish mackerel in or from the EEZ of the Gulf of Mexico or Atlantic, those fish must have been harvested on a commercial trip aboard a vessel with a commercial vessel permit/endorsement. A king mackerel permit is required to sell king mackerel and a Spanish mackerel permit is required to sell Spanish mackerel.

Option b. The Gulf Council's jurisdiction

Motion: In Action 1, that Alternative 4, Option a. be the preferred alternative.

Alternative 4: Allow two-for-one permit reduction in the king mackerel commercial fishery similar to the system for Snapper-Grouper Unlimited Permits.

Motion carried with no opposition.

Motion: To move Action 4 to the considered but rejected section.

Motion carried with one opposition.

Motion: In Action 5, to add a new Alternative 5.

Alternative 5: To obtain or renew a commercial permit for king or Spanish mackerel, at least [Option A] 75% or [Option B] 50% of the applicant's earned income must have been derived from commercial fishing or from for-hire fishing during one of the three calendar years preceding the application.

Motion carried with no opposition.

Motion: In Action 5, to move Alternative 2 to the considered but rejected section.

Alternative 2: If established in Action 2, establish an income requirement for the cobia permit consistent with the requirements for Gulf and South Atlantic commercial king and Spanish mackerel permits. Maintain existing income requirements for Gulf and South Atlantic commercial king and Spanish mackerel permits.

Motion carried with no opposition.

Red Drum

Motion: To request that the SEFSC update the 2008 red drum sampling protocols from Tab I, No. 3(a) by the June 2013 Council meeting.

Motion carried with no opposition.

Motion: To request that the SEFSC work with the states to identify relevant and pertinent data that may be useful for a formal Gulf-wide stock assessment, including current state escapement rates.

Motion carried with no opposition.

Motion: To put red drum in the open slot in the 2016 SEDAR schedule.

Motion carried with no opposition.

Motion: To direct staff, the appropriate NMFS personnel, and state personnel to develop a research plan for the collection of red drum in the EEZ and that harvest not exceed 20,000 fish, as recommended by the Gulf Council's Red Drum Special Working Group.

Amendment: To remove the word "harvest" and replace it with "fishery independent study".

Amendment carried.

Motion as amended: To direct staff, the appropriate NMFS personnel, and state personnel to develop a research plan for the collection of red drum in the EEZ and that the fishery independent study not exceed 20,000 fish, as recommended by the Gulf Council's Red Drum Special Working Group.

Substitute motion: To request that NMFS work with state fishery agencies to develop a research plan for red drum and to give the Council a status update at the August 2013 Council meeting.

Substitute motion carried 10 to 5.

Reef Fish

Amendment 39 - Regional Management

Motion: In Action 1, that Alternative 2 be the preferred alternative.

Alternative 2: Establish a regional management program that delegates authority to a state or states to establish certain management measures for the harvest of an assigned portion of the recreational red snapper quota.

Motion carried with no opposition.

Motion: To untable the motion that was made in Reef Fish Committee.

Motion carried with no opposition.

Untabled motion: To request that the Chairman draft a letter to each of the states informing them that the Council had selected delegation as a preferred alternative and outlining what the responsibilities of the states will be under a regional management delegation scenario. To request that the states advise us of their willingness to accept delegation, their agreement to prohibit landings when the state projects or determines that its individual catch limit has been harvested, and a description of how the state would calculate the projected season length and/or monitor landings to support in-season closures.

Alternative 4: Allow individual regions to establish recreational red snapper minimum size limits from 14 inches to 18 inches TL in the Gulf.

Alternative 6: Allow individual regions to establish closed areas within the EEZ adjacent to their region that applies only to vessels registered within their region.

Motion carried 9 to 6.

Motion: In Action 5, that the preferred alternative be Alternative 2.

Alternative 2: Exclude the provision requiring the vessels with Gulf charter vessel/headboat permits for Gulf reef fish from complying with the more restrictive of federal red snapper regulations when fishing in state waters.
