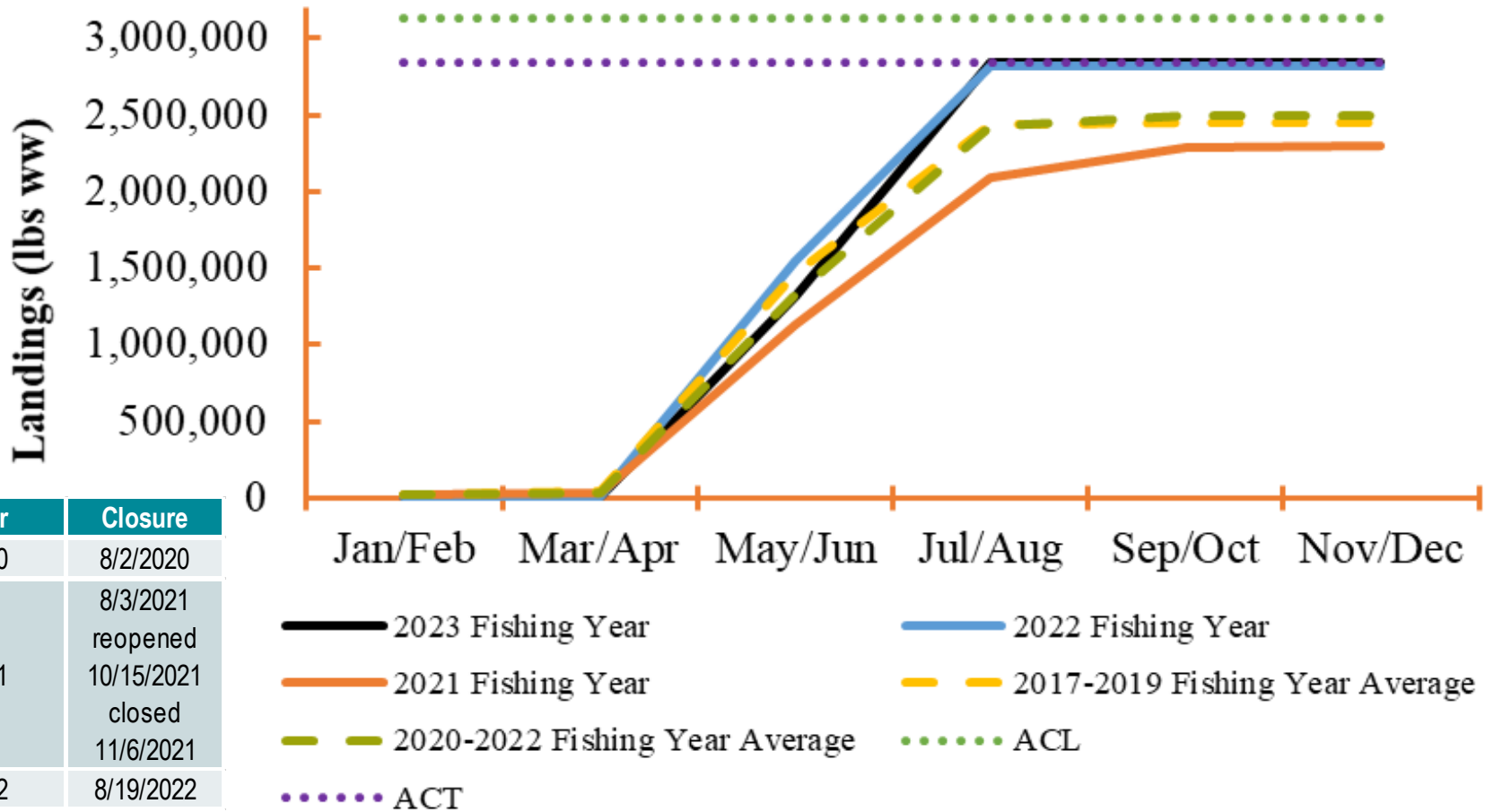


Notes on Landings Data

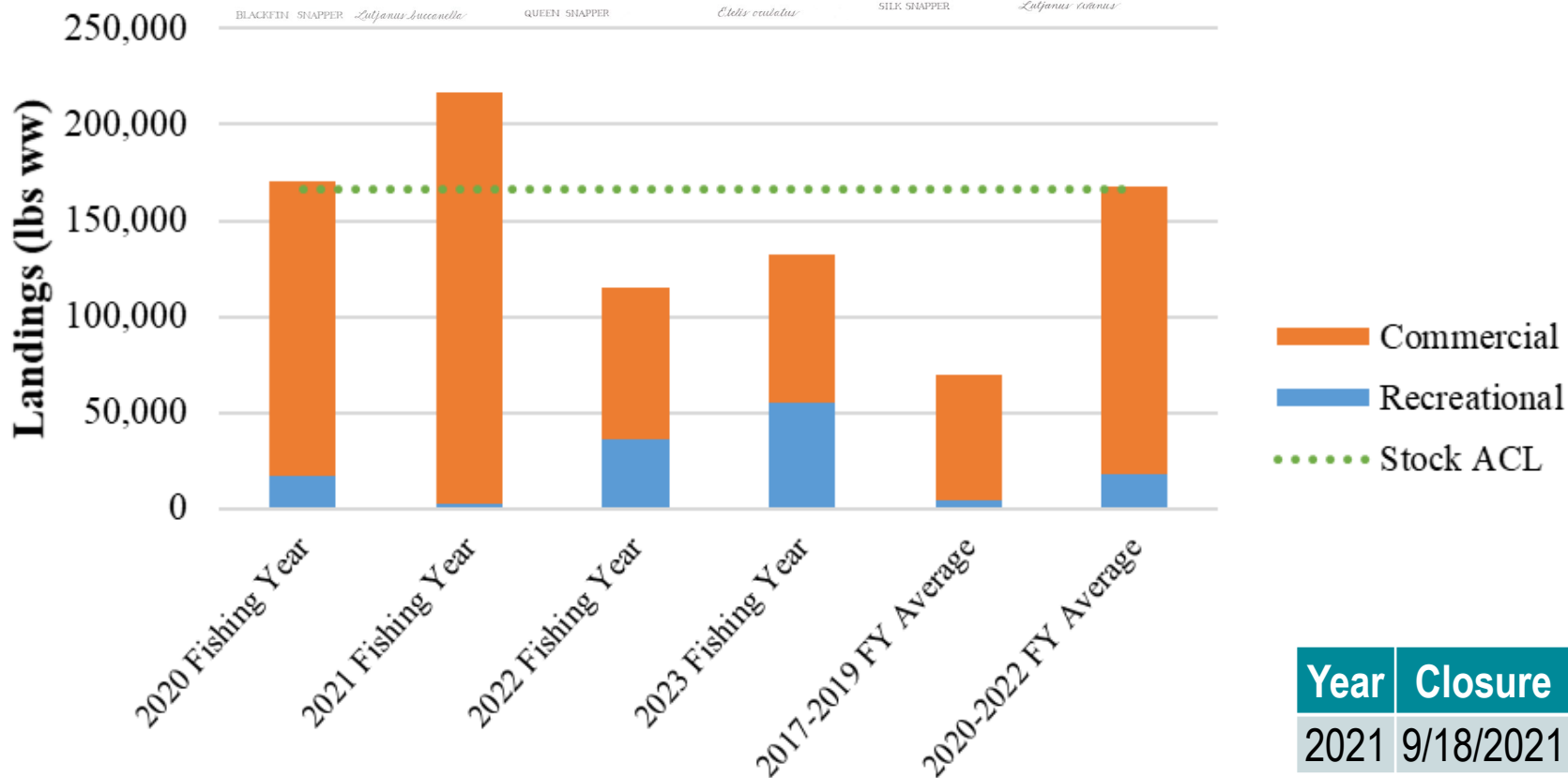
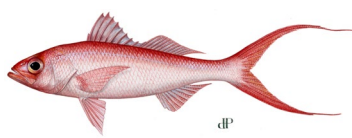
Effective January 1, 2024, the commercial ACL was reduced to 65,720 lbs and ACT to 58,650 lbs.

Greater Amberjack Recreational Landings



Note: 2019/2020 to 2022/2023 recreational ACL is 1,309,620 lbs and ACT is 1,086,985 lbs in MRIP-CHTS units. Fishing year is August 1 through July 31. There is a seasonal closure November 1 – April 30 and June 1 – July 31. For the 2022/2023 fishing year, NMFS modified the seasonal closure to be August 1-31 and November 1 - July 31. Effective July 17, 2023, to present, the recreational ACL is 404,000 lbs and ACT is 335,320 lbs in MRIP-FES units. The 2023/2024 recreational fishing season was August 1 – 25, 2023. Pending implementation of the GAJ FW, seasonal closure would be modified to August 1 – 31 and November 1 - July 31.

Mid-Water Snapper Recreational Breakdown



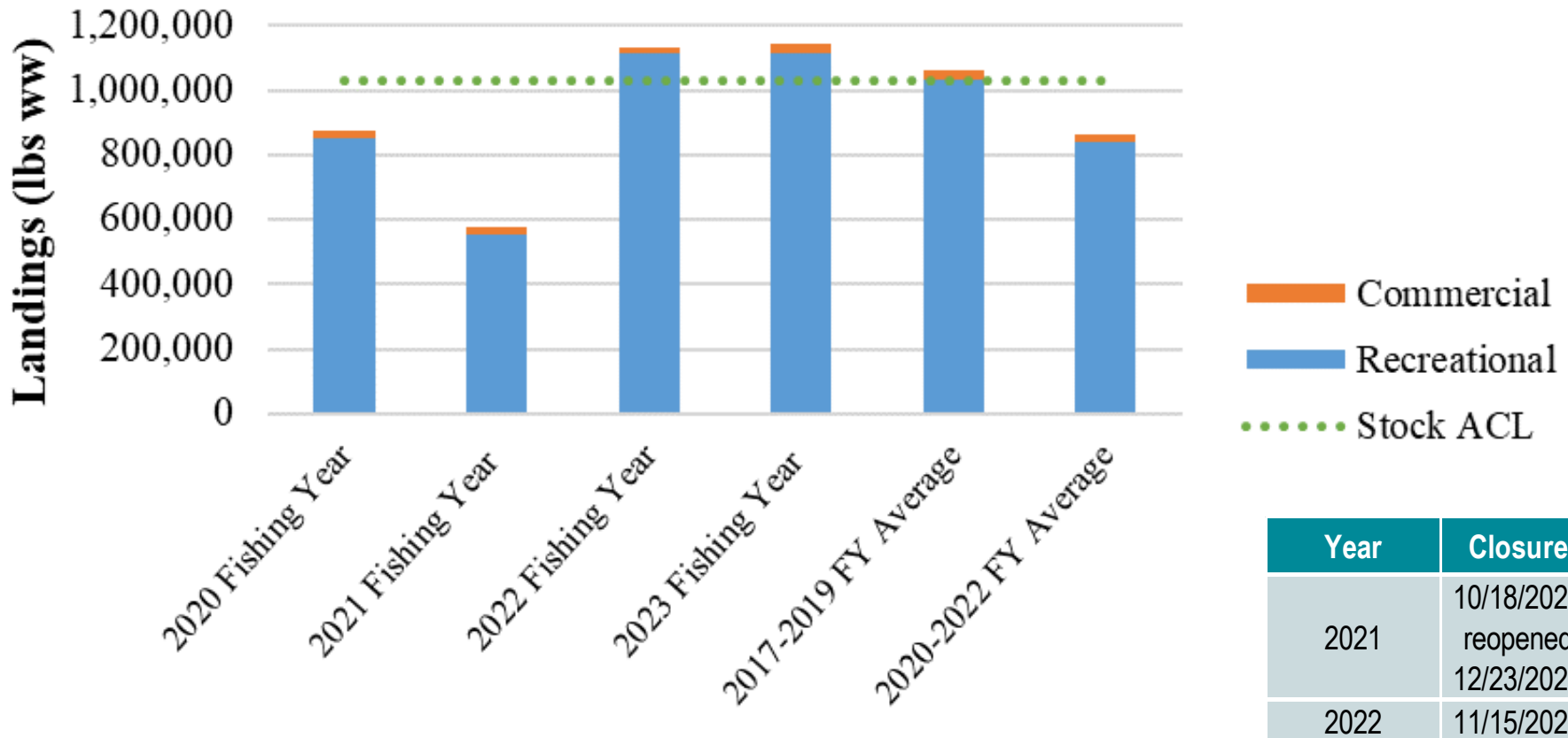
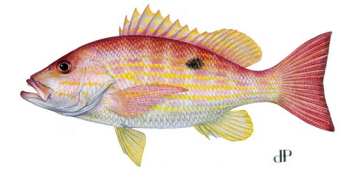

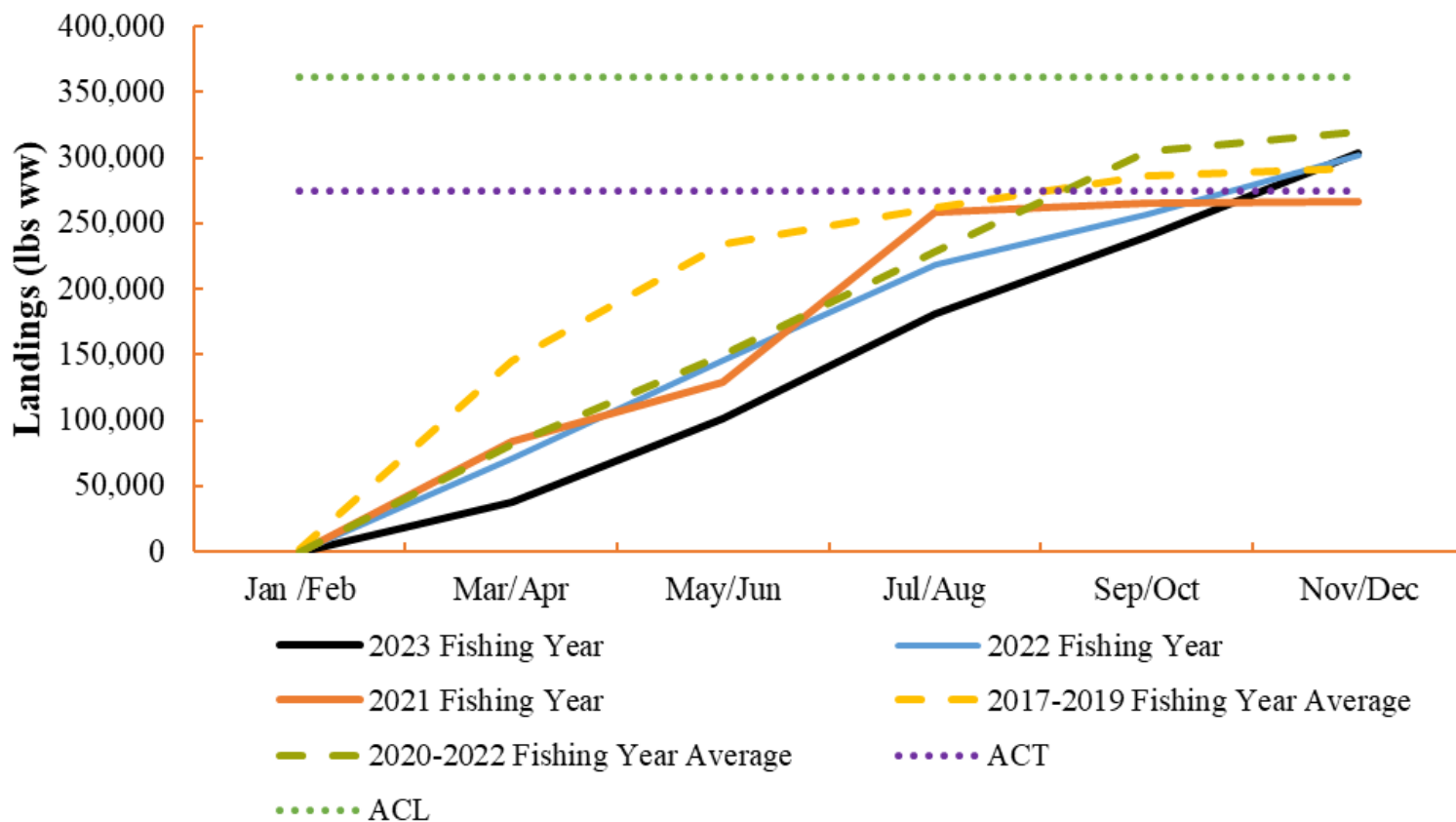
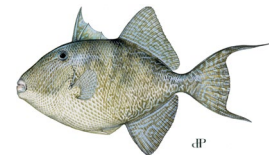
Gray Triggerfish Commercial Landings

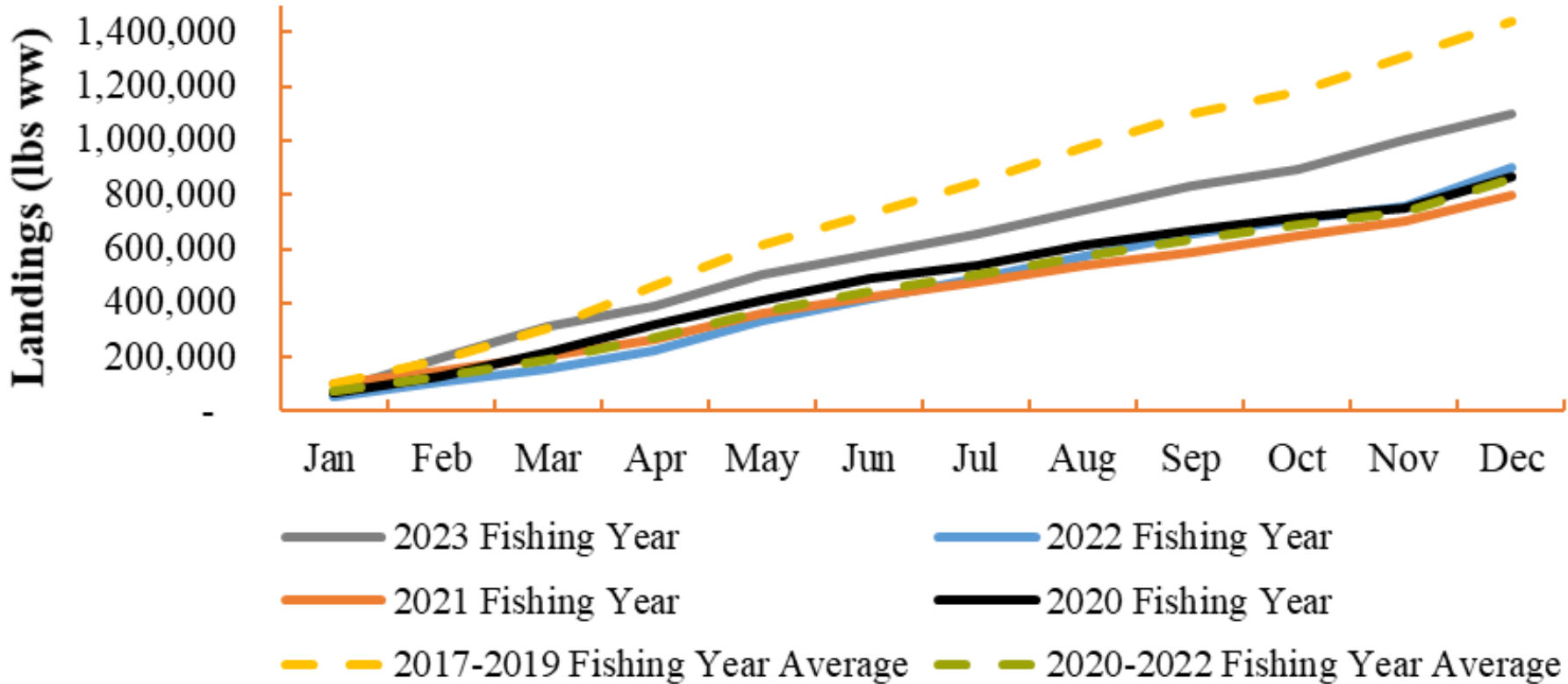

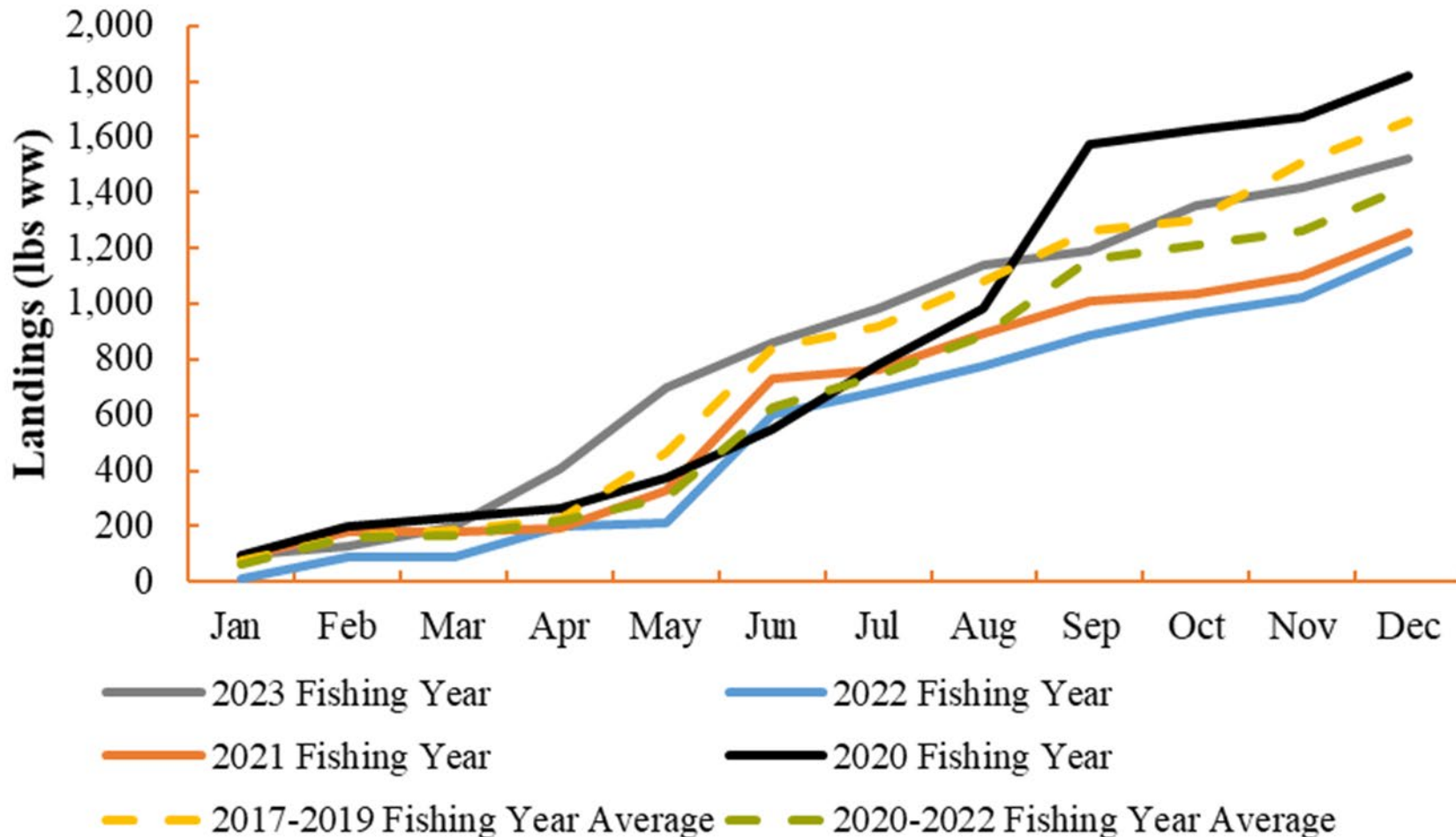

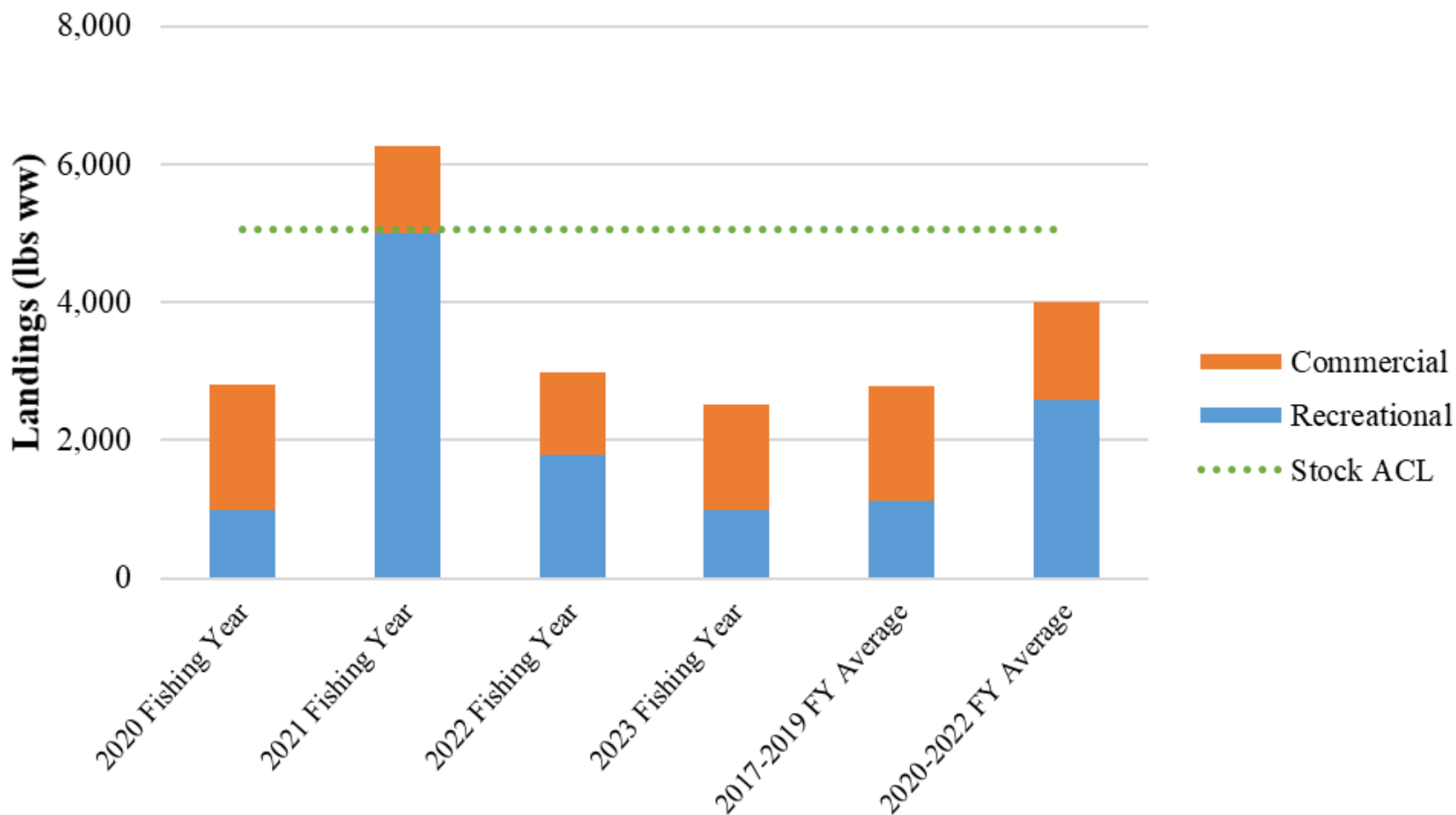

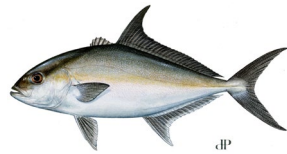

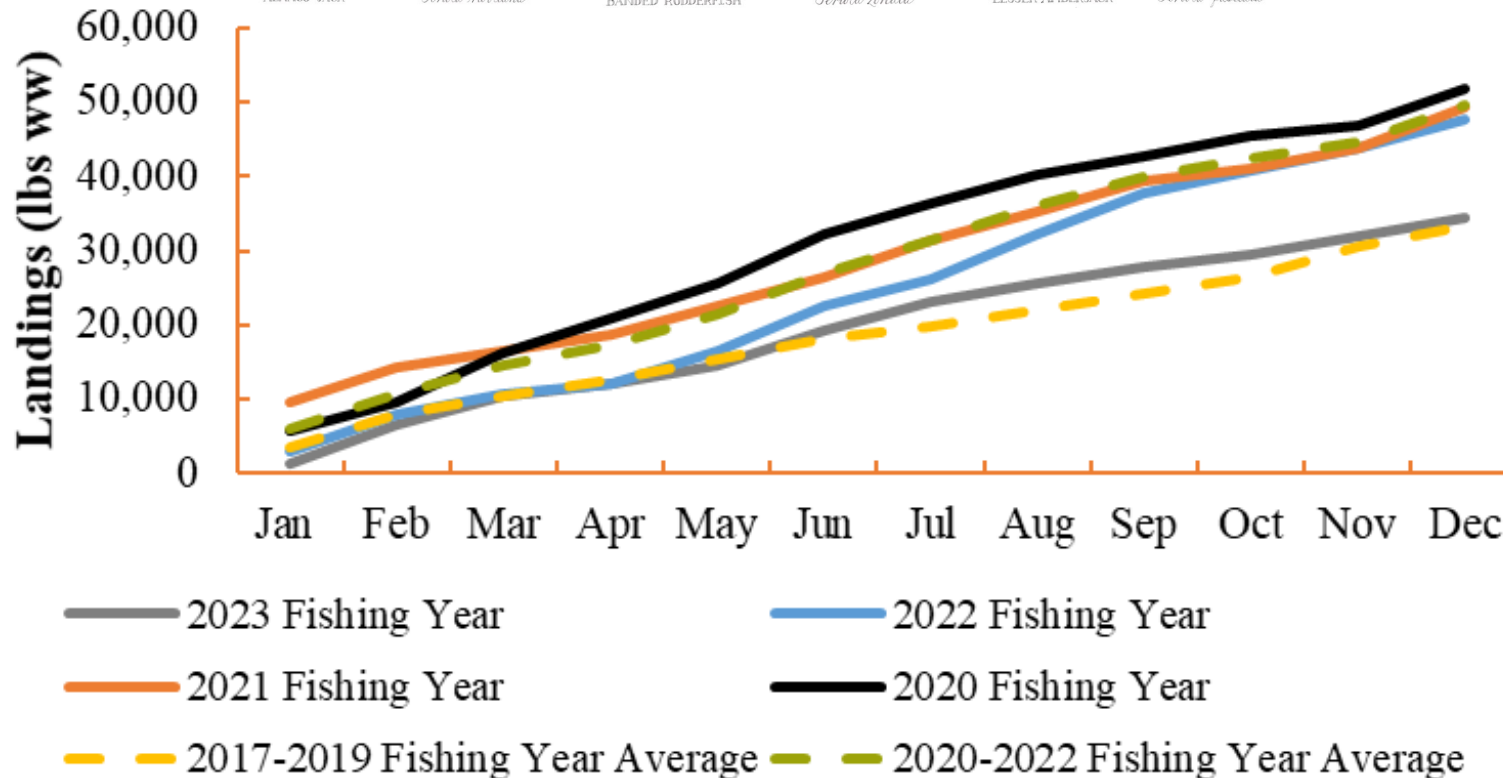

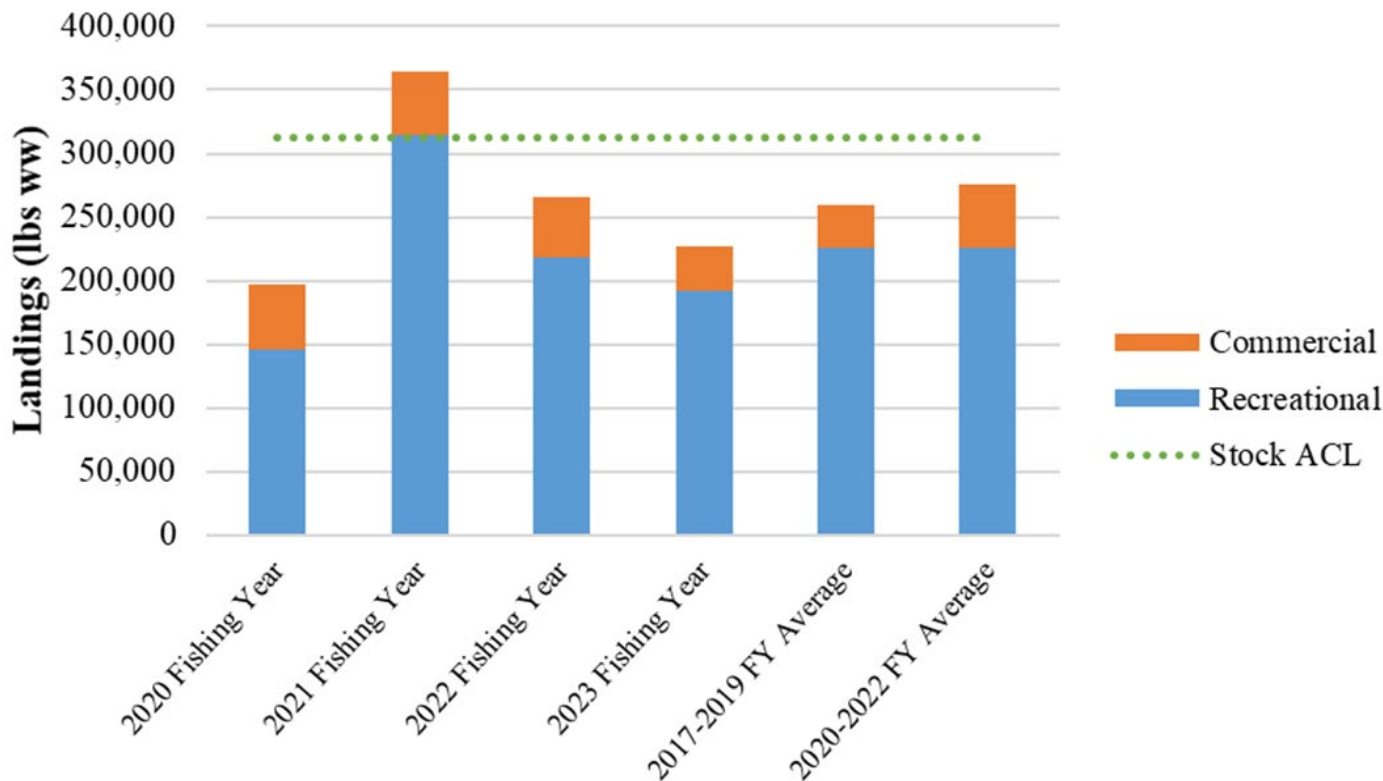

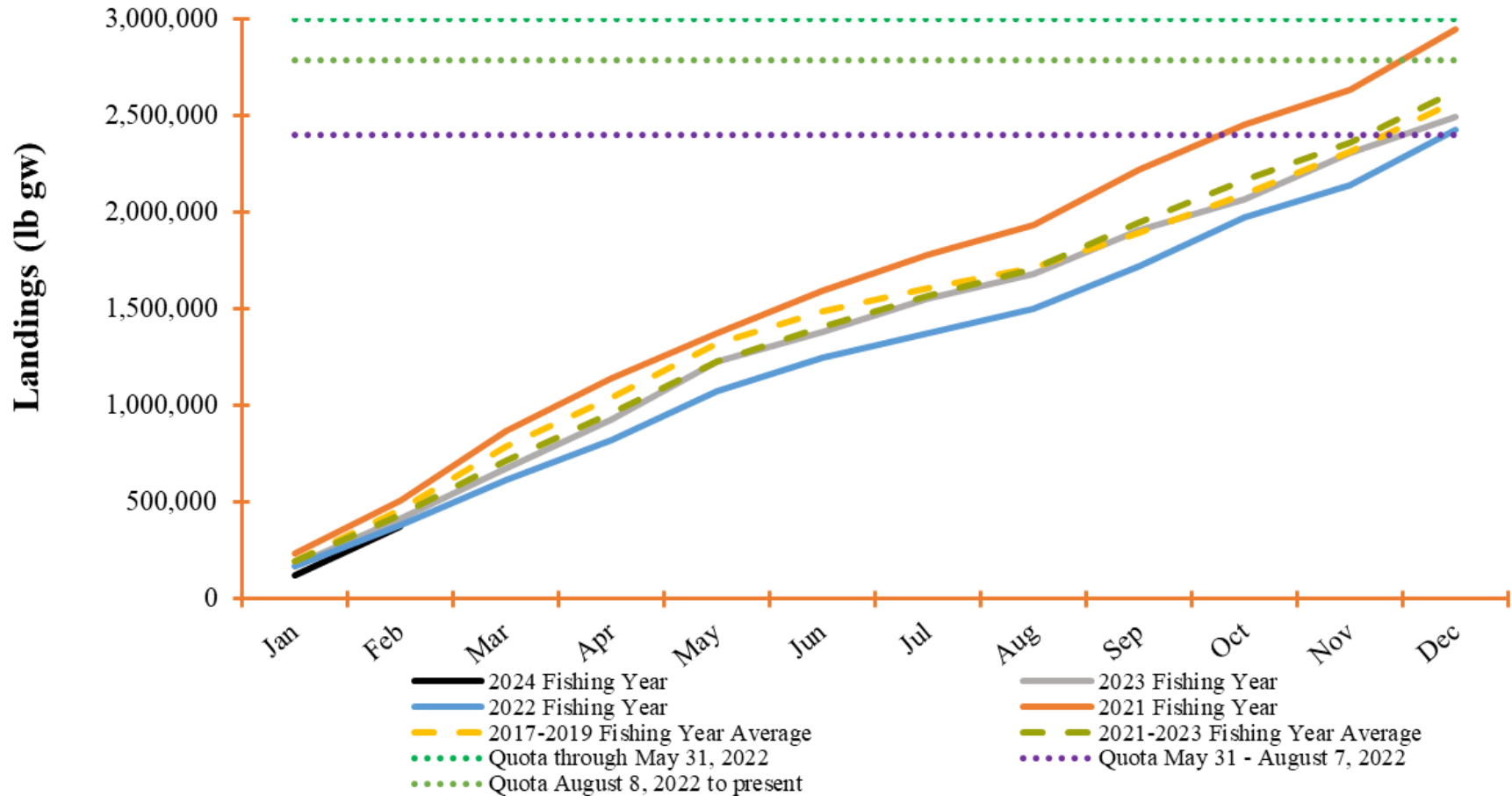

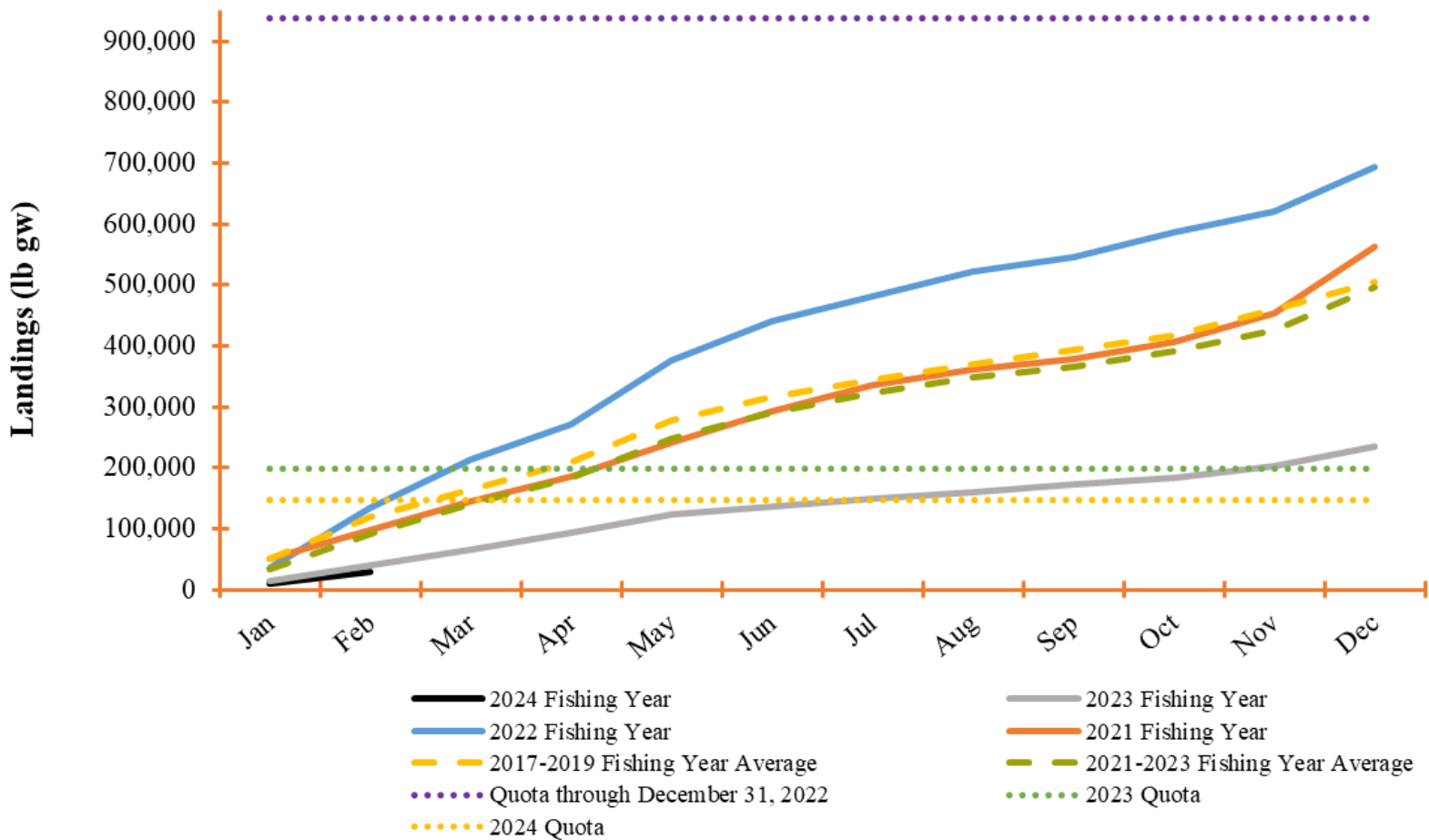

Red Grouper IFQ Landings



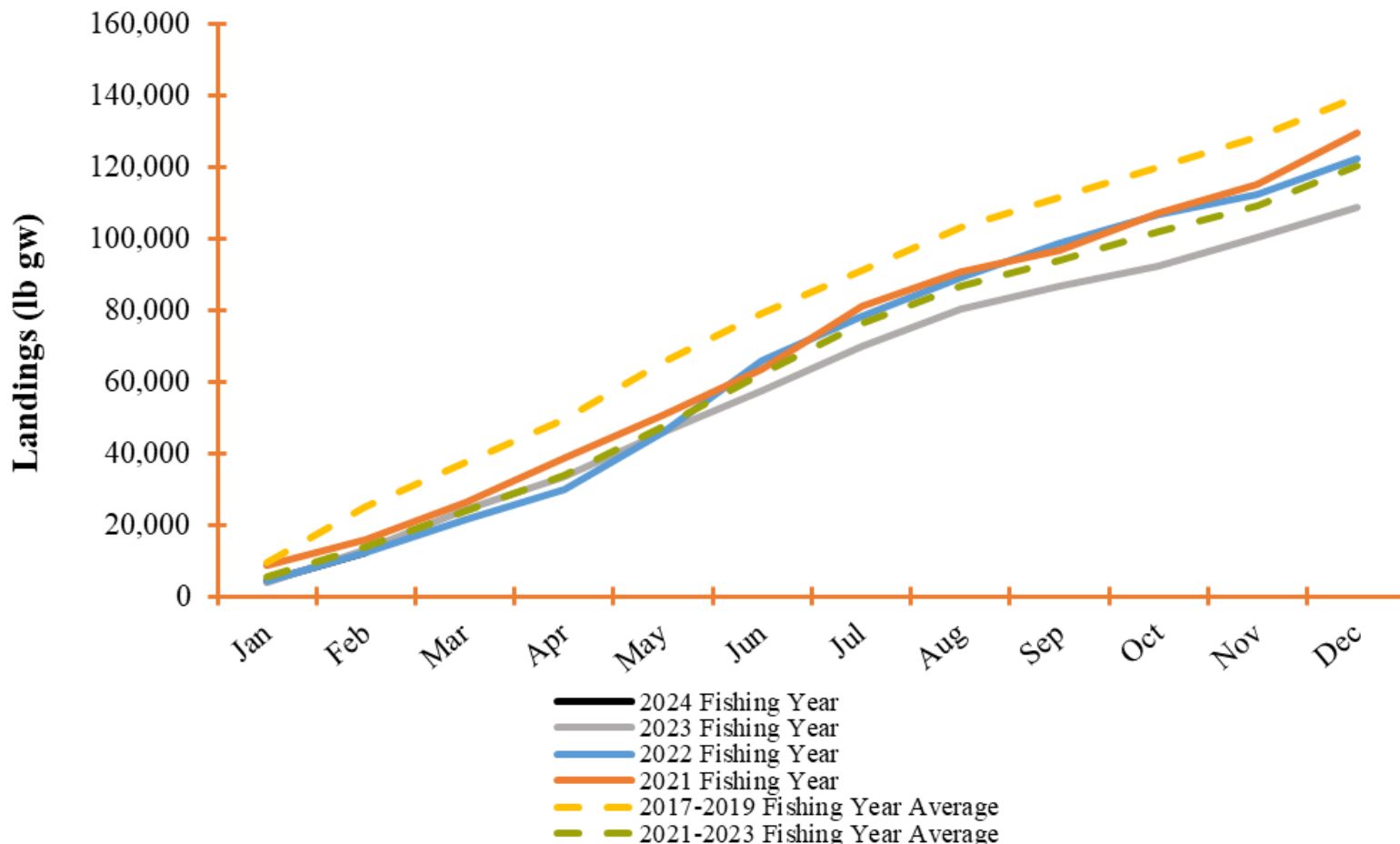

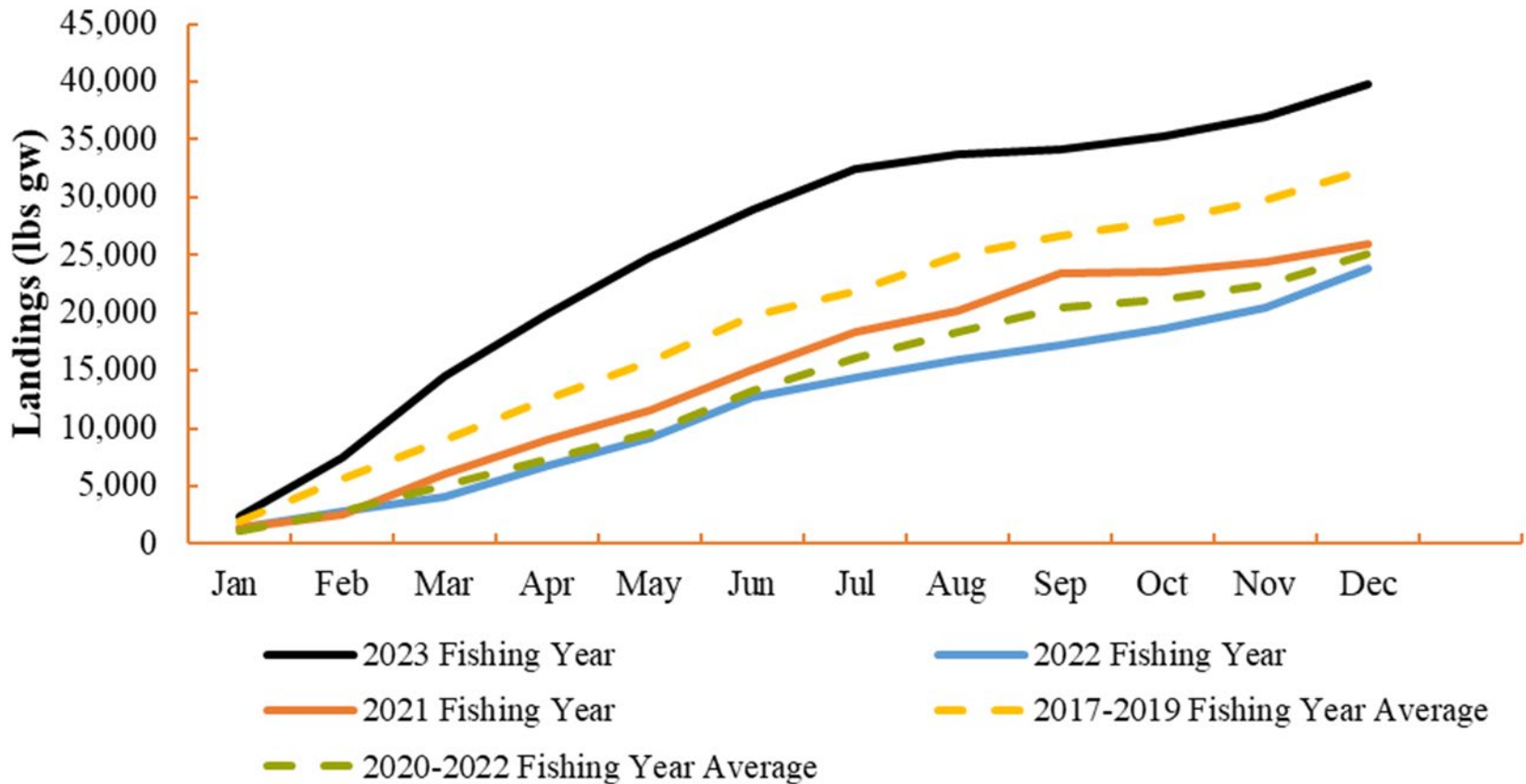
