Dear Mr. Strelcheck,

During its October 2023 meeting, the Gulf of Mexico Fishery Management Council (Council) approved a motion to delay any changes in allocation between the commercial and recreational sectors of any Gulf fishery resources that are subject to the Marine Recreational Information Program's Fishing Effort Survey (MRIP-FES) until such time that the 2024 pilot study has been completed and deemed consistent with best scientific information available by the Council's Scientific and Statistical Committee (SSC).

During its January 2024 meeting, the Council discussed its allocation review schedule and completed amendments which include allocation reviews and reallocation initiatives. Following its deliberations, the Council adopted a motion to approve an updated allocation review schedule. The revised schedule assumes that the ongoing MRIP-FES pilot study and subsequent SSC evaluations will be concluded in early 2026 and that updated recreational data should be available for use in management later in 2026.

The time intervals and expected start dates for allocation reviews are provided in the table appended to this letter. The Council will publish this updated allocation review schedule on its website and looks forward to continued collaboration with the Southeast Regional Office and Science Center on allocation reviews. In addition to the scheduled allocation reviews, the Council may initiate supplementary allocation reviews at any time. For example, the Council could initiate an allocation review should relevant new information, e.g., stock assessment results or data recalibration, be made available.
