iv Oral or written communications provided to the Council are public documents. These communications will be made available to the public in their entirety and maintained by the Council as part of its permanent record. Further, knowingly and willfully submitting false information to the Council is a violation of Federal law.

Y Anyone wishing to use electronic visual aids during public testimony must provide staff with a copy of the material at least one hour before comment begins to allow for a virus scan of said material.

ⁱThe established times for addressing items on the Council agendas may be adjusted as necessary to accommodate the timely completion of discussion relevant to the agenda items. Public testimony may begin earlier than 2:00 pm CDT on October 25, 2023 but will not conclude before that time. Public testimony may end before the published agenda time if all registered in-person and virtual participants have completed their testimony.

ⁱⁱ Persons wishing to give public testimony **virtually** must sign up on the Council website beginning on the first day of the Council meeting. Registration closes one hour before public testimony begins. During public testimony, the Council will hear testimony related to final actions of the Council and pertinent agenda items. Time constraints may limit individual speaking time as determined by the presiding officer.
