2023 Red Snapper Season

- 2023 allocation for private recreational and state charter harvest was 934,587 pounds.
- The private recreational and state charter red snapper season opened as a 7 day a week season on May 26th in both state and federal waters with a 3 fish bag limit.
- A bag limit adjustment to 4 fish per angler was made beginning on July 17th .
- Longest red snapper season since state management at 220 days.
- 878,464 pounds (94%) were harvested by private recreational and state charter anglers.



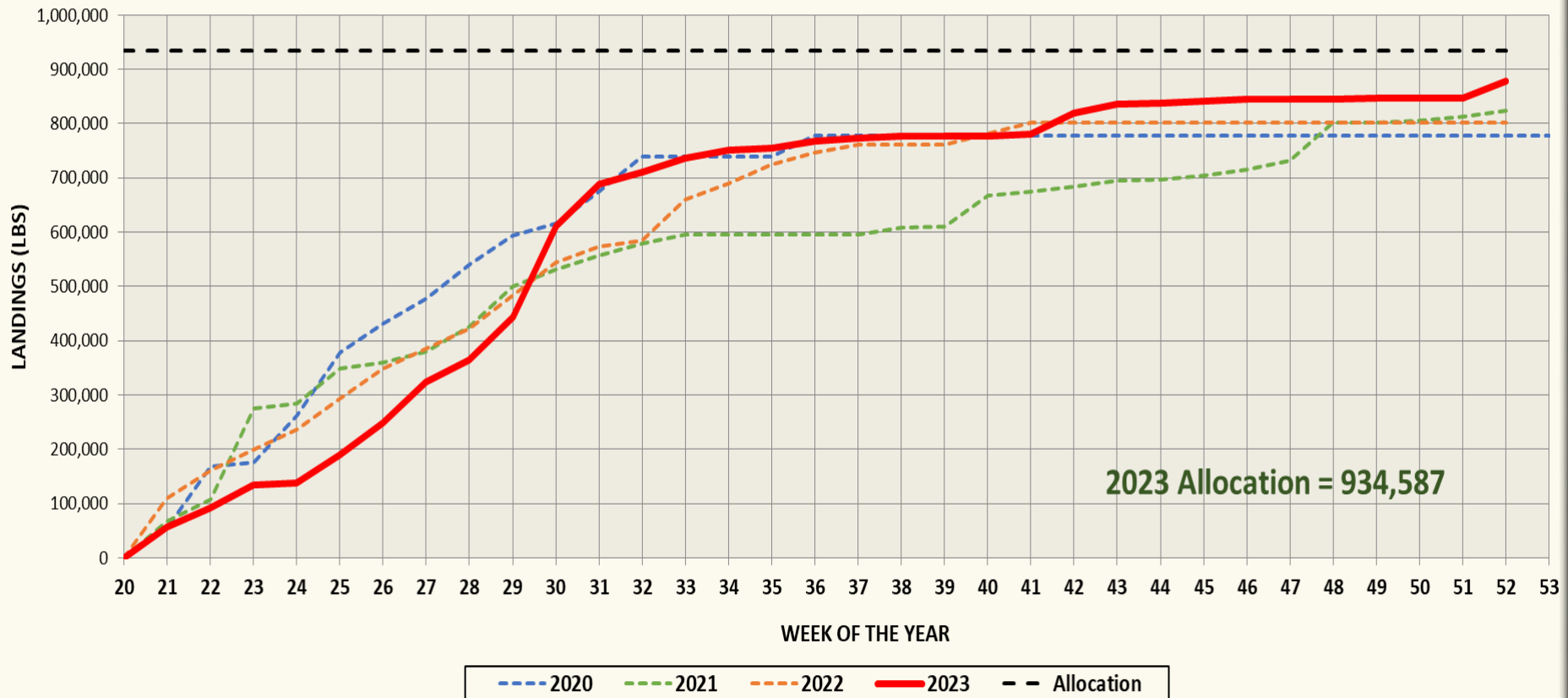
2023 Red Snapper Season

- Harvest by sector:
 - Private Recreational – 823,355 pounds
 - State Charter – 55,109 pounds
 - Federal Charter (not part of allocation) – 156,105 pounds
- 56,123 pounds (6%) of allocation were not harvested.
- No carryover provision is in place to allow for use of the remaining 2023 allocation.

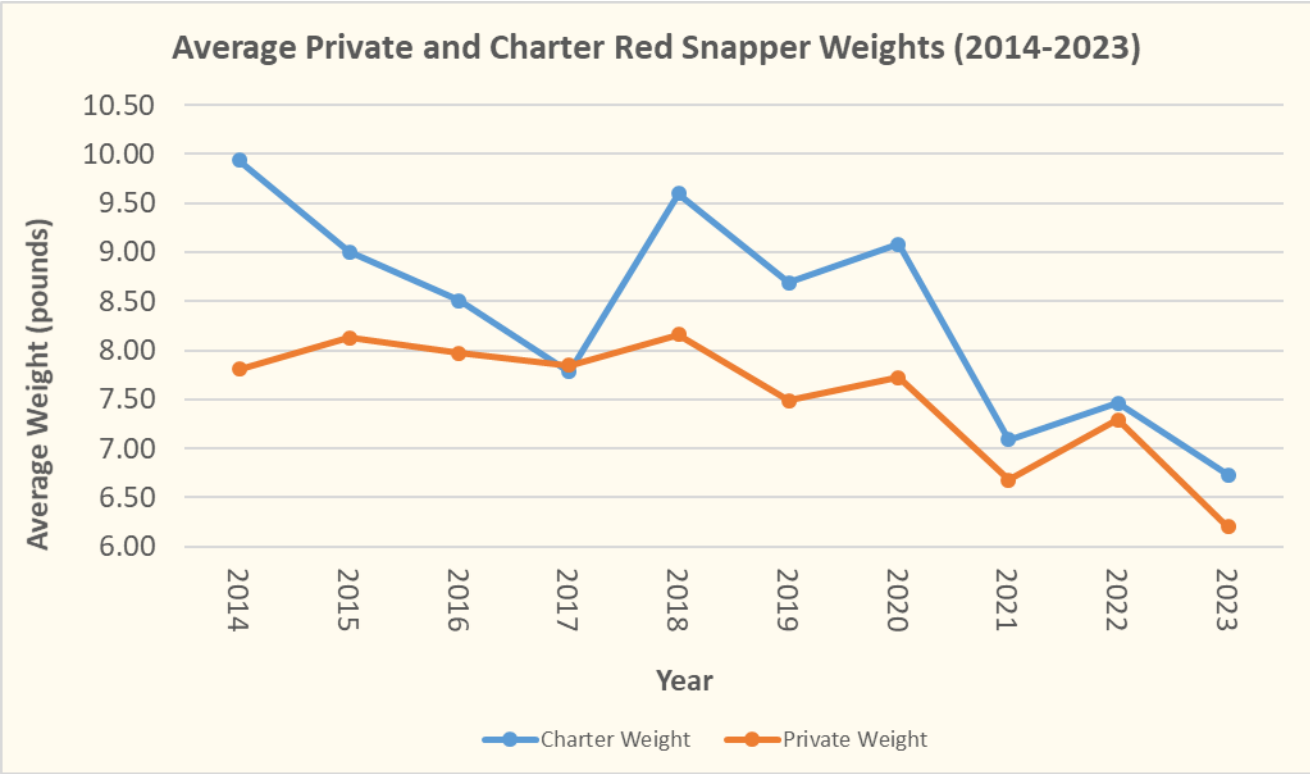
LOUISIANA'S LA CREEL RED SNAPPER LANDING ESTIMATES

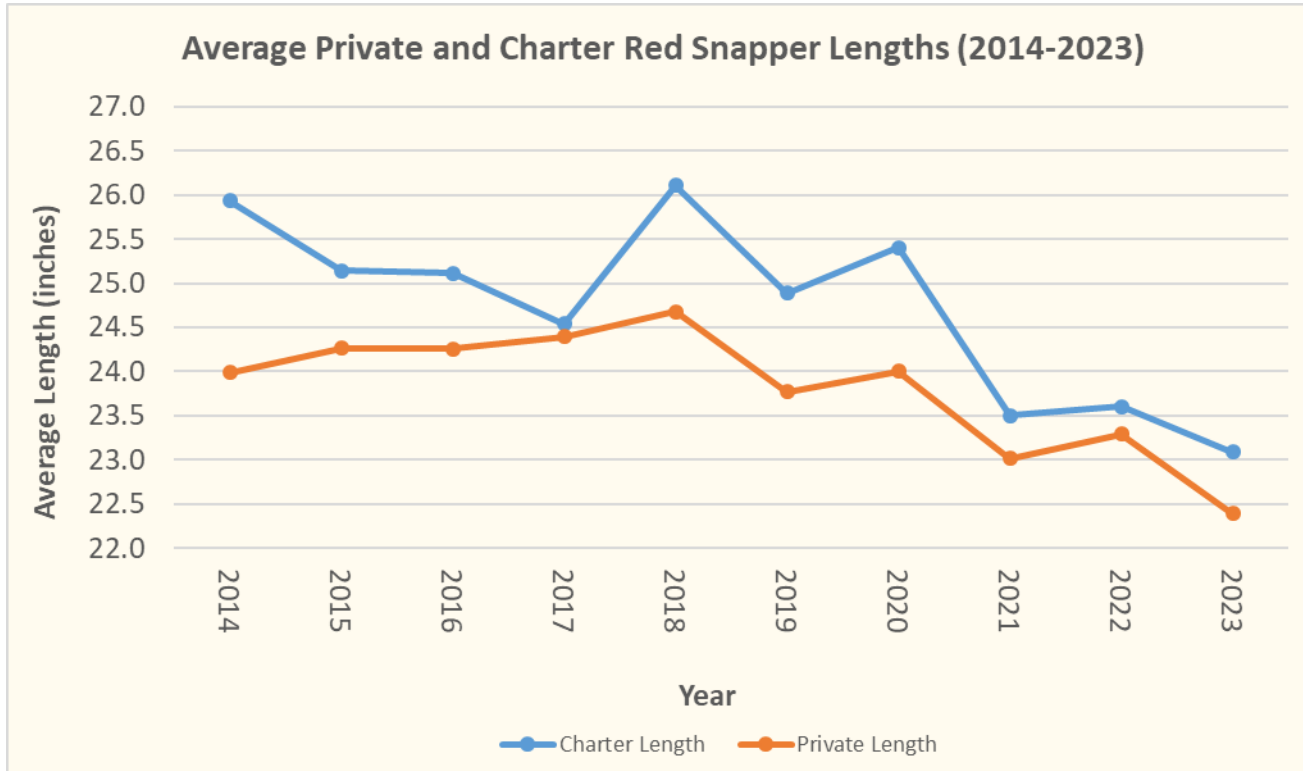

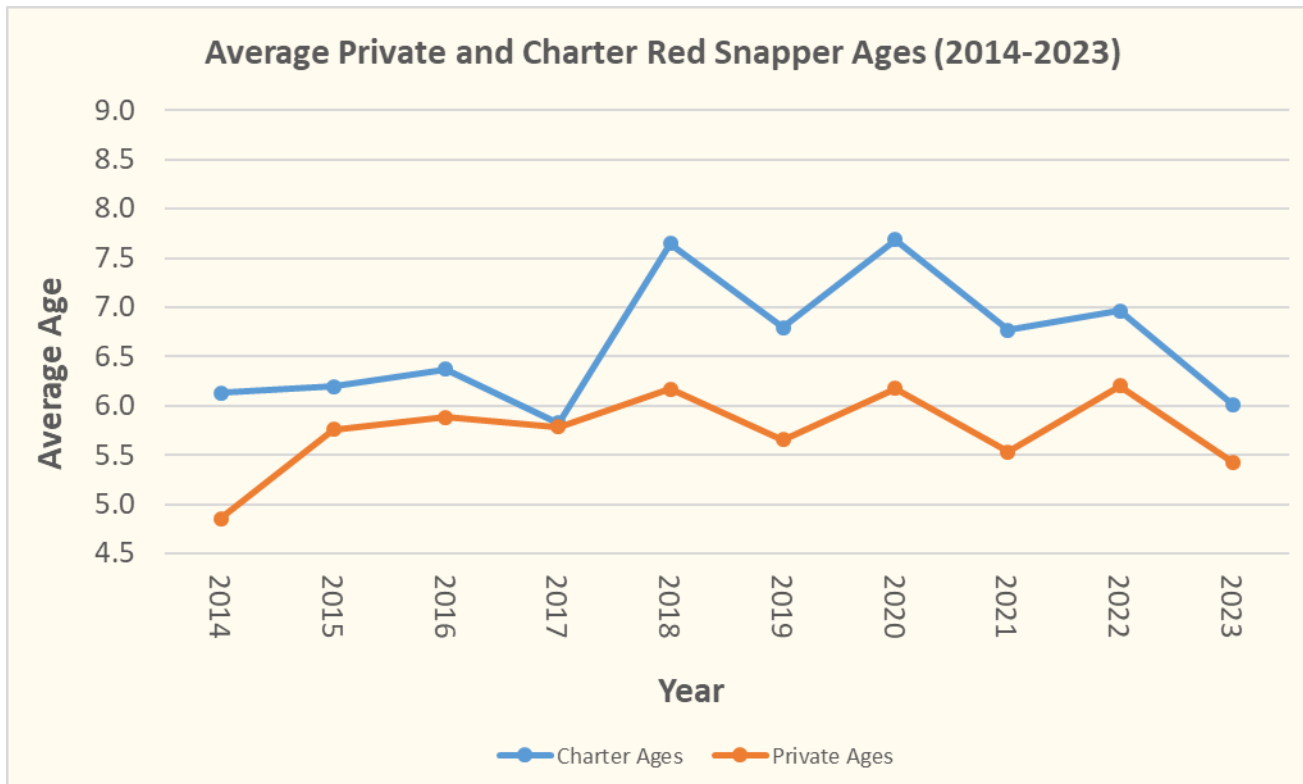

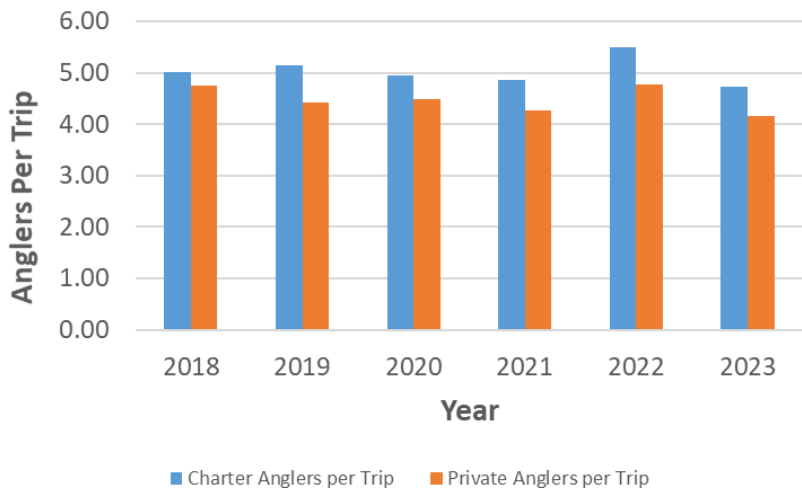

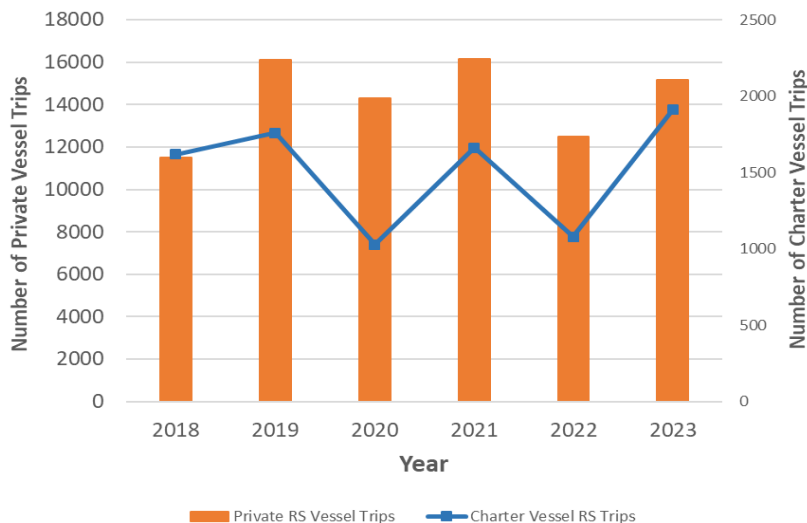
