

## Gulf FEP (Process)

- ETC recommends including opportunities to review and reassess the FEI list and loop to ensure the success of the FEP
  - Annual revisions to the FEI list may entail a large workload, a 3-5 year assessment period may be more appropriate.
- Persistent feedback/communications with the public is ideal.
